# CRITTENDEN COUNTY BOARD OF TRUSTEES REGULAR MEETING – January 26th, 2023 – 5:00 p.m.

- David Anderson, CPA, presented the June 30, 2022 Financial Statement David gave an overview of the report and, as noted in the report, the library's assets exceeded liabilities representing an "increase of \$26,504 over the net position from June 30, 2021." David allowed for questions.
- Brandie commented on the current financial statement noting there are no other grants this year, Motor Vehicle tax share is down, and there has been no Franchise Tax payment made. During Brandie's report she stated that the library needed a new copy machine. A motion was made by Susan Yarbrough to purchase a new copy machine, second by Melissa Tabor. Motion passed. Brandie also noted that the KaCo appraisal of the library building and contents came in at \$2,193,100. The December 2022 Treasurer Report was approved on motion/second by Browning/Tabor.
